LINKAGES

Dystonia is a neurological muscle disorder that causes uncontrollable, painful spasms in one or more parts of the body.

- Dystonia affects an estimated 500,000 people in North America alone, affecting more people than muscular dystrophy, Huntington's disease and Lou Gehrig's disease combined.
- Different forms of the disease affect the face, neck, throat, eyelids, arms, legs or torso. This devastating disease can appear in children and in adults alike.

Parkinson's disease is a disorder of the central nervous system caused by a change in the part of the brain that controls movements like walking and balance.

- Symptoms include tremor, slowness of movement, muscle tightness and problems with balance.
- Parkinson's may appear at any age, but it's most common in people over 50 and rare in those under 30.

Now into our second decade of operation, Fiscal 2006 was a year of positive change and a year of hard questions on many fronts.

Perhaps the biggest change of all was the appointment of Ted Dawson, MD, PhD to lead our Scientific Advisory Board. Spearheading our research interests, Dr. Dawson is helping us examine the road to the future, and we are pleased and honored to benefit from his considerable expertise and his fresh perspective.

Answers to our questions will carry us through the coming years. We maintain that high-risk, high-reward science equals results, but who has the link to the most promising hypotheses? Should our investments in scientific research be refocused? We have been able to fund a strong body of far-reaching scientific research through the years but the challenges are growing. Can the private sector continue to bridge the gap in government funding cutbacks of medical and scientific research? How do we find innovative, cost-efficient ways to build and grow our base of support to help achieve our goals?



Multi-year grants provide critical funding stability, which is particularly valuable to a small foundation like ours. We are most grateful to the Dekker Foundation for providing leadership in this direction. Their grant provides \$50,000 a year over five years, totaling \$250,000. Committed to us in FY 2006, the award will be made in 2007.

Vital sources of revenue continue to include personal outreach and events like our annual golf invitational, theater benefit, Young Professionals gatherings and others. This year, thanks to the creativity and strong commitment of one man, we widened our circle of support even further around the country. Motivated to help his mother, who struggles with Parkinson's disease, Brian Dugan volunteered to organize a team of New York City Marathon runners that would raise funds for our organization. The result was a high-visibility, high-return event with very low cost to us. In a pre-Marathon speech at Gracie Mansion, New York City Mayor Michael Bloomberg pointed to our Foundation as an example of how this initiative helped a non-profit organization.

We look to the coming year with optimism. The research we have funded and continue to fund holds promise for millions of people. Our ongoing commitment to find better treatments and cures for dystonia and Parkinson's disease is strengthened by linking the support of old and new friends alike to crucial outcomes.

LOOKING FOR LINKS TO DYSTONIA AND PARKINSON'S DISEASE

A Link between Dystonia and Parkinson's Disease?

Bonnie Strauss and her father Louis Bachmann began The Bachmann-Strauss Dystonia & Parkinson Foundation in January 1995 to search for answers and a cure. Bonnie has lived with spasmodic torticollis—a form of dystonia that causes involuntary neck spasms—for nearly 30 years. Her condition went undiagnosed for five years. Both Bonnie's mother and her grandmother had Parkinson's disease.

Bachmann-Strauss is the leading organization actively looking at the interface between dystonia and Parkinson's disease.

INCREASINGLY, RESEARCHERS ARE PROBING TO UNDERSTAND THE RELATIONSHIP BETWEEN THESE TWO NEUROLOGICAL DISEASES. Several of the hereditary dystonias have Parkinsonian as well as dystonic symptoms. In addition, dyskinesia, the uncontrollable movements that often characterize one of the side effects of Parkinson's disease treatment, is similar to the muscle spasms seen in dystonia.

There are now multiple lines of genetic, cell-biologic and pharmacologic evidence that dystonia and Parkinson's disease both compromise the function of the same dopamine-producing neurons in the brain that regulate movement.

In Parkinson's disease there is progressive death of these neurons, while in dystonia this dysfunction seems to be caused by altered neurotransmission but the dopaminergic neurons remain alive.

Understanding dystonia may help Parkinson's disease patients and vice versa. There is currently some evidence that the protein torsinA involved in dystonia may help these dopaminergic neurons survive some of the environmental toxins implicated in Parkinson's disease.





Human genetics is the main focus of Dr. Laurie Ozelius's research. Dr. Ozelius is The Bachmann-Strauss Professor at Mount Sinai School of Medicine.

Ted Dawson's highly-respected work and discoveries have led to innovative approaches and enhanced the development of new agents to treat neurologic disorders, such as stroke, Parkinson's disease, Alzheimer's disease and other neurodegenerative disorders. He is the Leonard and Madlyn Abramson Professor in Neurodegenerative Diseases and the Director of the Neuroregeneration and Repair Program in the Institute for Cell Engineering; Director of the Parkinson's Disease and Movement Disorder Center and Professor of Neurology and Neuroscience at the Johns Hopkins University School of Medicine in Baltimore, MD.

New SAB Chair Appointed; Scientific Review Streamlined

In FY 2006, following a national search, Ted Dawson, MD, PhD was appointed to chair our Scientific Advisory Board (SAB). This is the first time that this advisory board will be led by someone outside the New York region, significant because of our growing national and international research investments.

Under Dr. Dawson's leadership, we reevaluated and streamlined our grant application and review process. For the first time, we specifically requested grant applications for studies that explored the interface between dystonia and Parkinson's disease.

As Chair of the SAB, Dr. Dawson oversees our scientific portfolio, recommends overall direction and areas of scientific research to be funded, oversees the grant review process, chairs and establishes agenda for workshops, Think Tanks, and symposia. He succeeds C. Warren Olanow, MD, FRCPC, who chaired the SAB for the past ten years.

"The Foundation is taking a comprehensive approach to understanding the mystery of dystonia. Clues can come from a variety of sources. Since a large number of patients with Parkinson's disease develop dystonia, we have directed a portion of our research portfolio toward understanding the linkage between Parkinson's disease and dystonia. By linking Parkinson's disease and dystonia researchers together, we will accelerate our goal of curing dystonia."

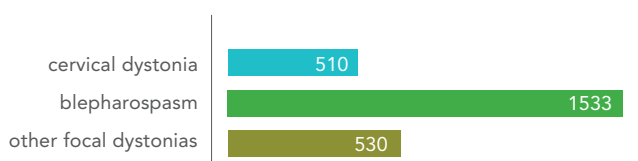
Fifth Annual Think Tank

Our Think Tank has increasingly become a well-attended and highly-productive forum. In the fall 2006 we brought together nearly 40 leading clinicians and research scientists to examine the latest developments in dystonia. Co-chaired by Ted Dawson, MD, PhD and Susan Bressman, MD, this prestigious, international group centered their discussion on the pathophysiology of dystonia, imaging results and surgical treatments like Deep Brain Stimulation. We are grateful to the Allergan Foundation and Medtronic for sponsoring this forum in 2006.

Workshop Focuses on Genetic Advances in Dystonia

A two-day workshop, held last February in Arizona and jointly organized by The Bachmann-Strauss Dystonia & Parkinson Foundation and the Dystonia Medical Research Foundation, took a fresh new look at the current status of genetic research and outlined future directions and opportunities for collaboration.

The participants agreed to work together to study families with three or more affected members. This should help to obtain statistically significant results and locate other genes for dystonias.



113 FAMILIES WITH THREE OR MORE AFFECTED INDIVIDUALS

Of the investigators represented at the meeting, population studies on dystonia are being carried out in Germany, the UK, Italy, China, Ireland and the U.S. Their overall tally was 113 families with three or more affected individuals; 510 people with cervical dystonia, 1,533 people with blepharospasm, and 530 with other focal dystonias.

ADVANCING THE PACE OF RESEARCH

In 2006, The Bachmann-Strauss Dystonia & Parkinson Foundation awarded research grants totaling \$850,000. These were made to individual researchers working at medical institutions around the world, as well as to the Dystonia Medical Research Foundation (DMRF) and to the Michael J. Fox Foundation to supplement the grants made through their organizations.

Small molecule microarray screening to identify novel ligands for torsinA

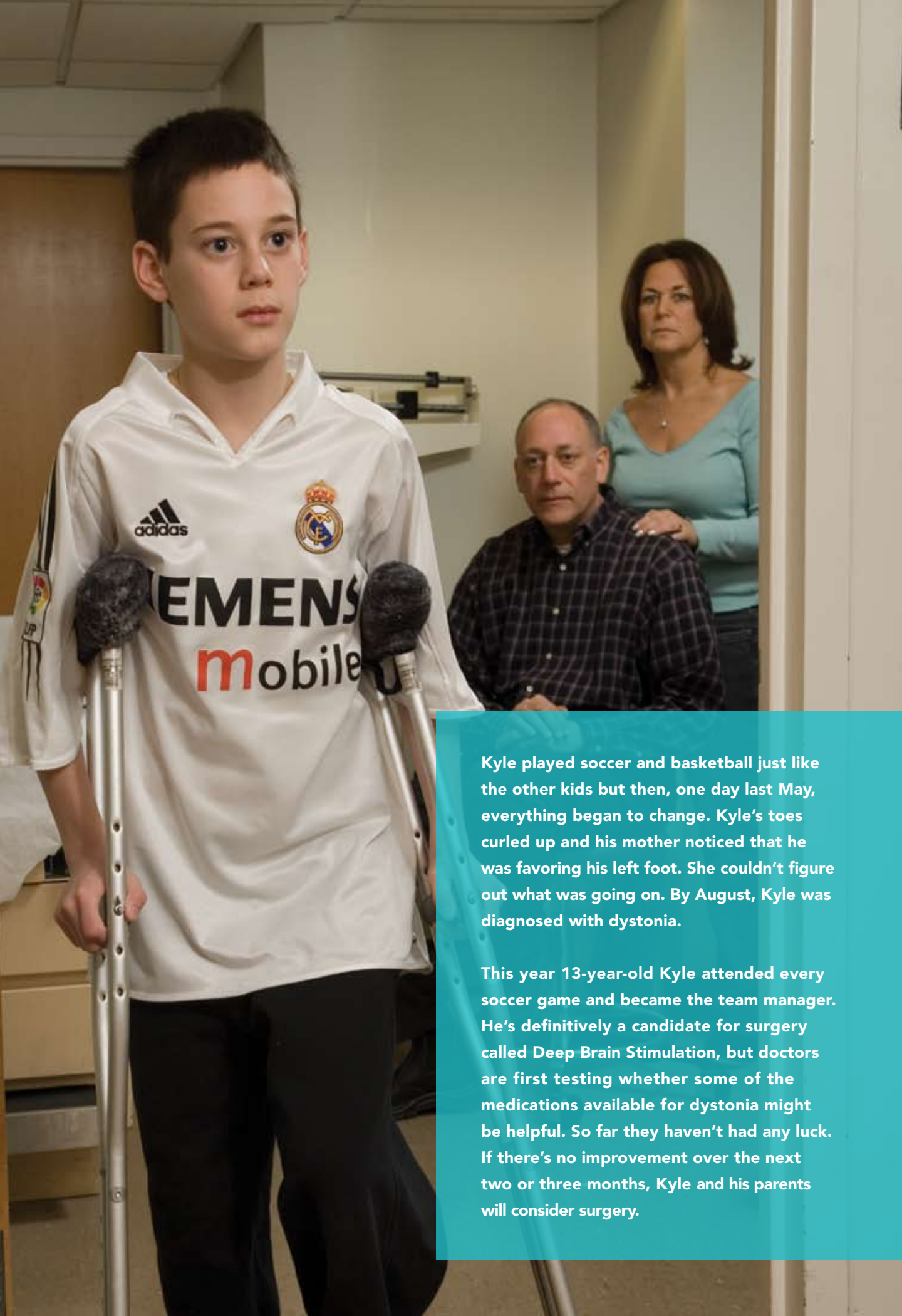
This research uses a novel screening technique that identifies chemical compounds known as "small molecules" which bind directly to the human protein torsinA or to its dystonia-linked mutant form. Sample compounds will be sent to other researchers for further testing. By looking for small molecules which prevent the effects of the mutant torsinA protein, the researchers hope to identify potential new therapeutic compounds for dystonia.

Genetic intervention strategies for DYT1 dystonia

The ability of Deep Brain Stimulation to alleviate symptoms in DYT1 dystonia supports the possibility of a cure. Cell culture models will be used to screen drugs which can normalize the altered state of skin cells from DYT1 patients to identify ones which can modulate torsinA activity.





Kyle played soccer and basketball just like the other kids but then, one day last May, everything began to change. Kyle's toes curled up and his mother noticed that he was favoring his left foot. She couldn't figure out what was going on. By August, Kyle was diagnosed with dystonia.

This year 13-year-old Kyle attended every soccer game and became the team manager. He's definitely a candidate for surgery called Deep Brain Stimulation, but doctors are first testing whether some of the medications available for dystonia might be helpful. So far they haven't had any luck. If there's no improvement over the next two or three months, Kyle and his parents will consider surgery.

Investigating small molecule therapeutics for torsion dystonia

This grant is aimed toward expanding promising data on FDA-approved small molecules that exhibit the capacity to enhance torsinA activity. Using a microscopic worm, *C. elegans*, to screen for potential drugs that modify the activity of torsinA, this collaborative project may represent lead candidate therapeutics for DYT1 dystonia.

Functional correlates of GPi Deep Brain Stimulation in primary dystonia

For dystonia patients who do not respond to medical therapy, surgical treatment with Deep Brain Stimulation (GPi DBS) can reduce symptoms. This study examines how brain metabolism and activation are influenced by DBS in this disease.

Generation of mouse model of L-DOPA-responsive dystonia (DRD)

A new mouse model will be developed to help understand the abnormalities within the basal ganglia that result in dystonia. This mutation causes a range of disorders from dystonia to Parkinsonism and will provide a critical tool for insight into their relationship and developing new therapies.

Why is dystonia more frequent in females than males?

For many dystonias, women significantly outnumber men but the reasons are unknown. Using an inbred mouse line in which dystonia occurs almost exclusively in females, the goal is to clarify the role of ovarian hormones in the expression of their dystonia.

Novel siRNA-based experimental therapy for DYT1 dystonia

Using a mouse model for DYT1 dystonia that they developed, Dr. Li and his team will test a new siRNA-based treatment for DYT1 and other dystonias. Scientists use siRNA, or small interfering RNA, to inhibit genes that behave abnormally.





You'd never know it by looking at him now, but Albert's whole world began to spiral out of control when he was 9 ½. At first, his left foot dragged and his body seemed off-balance. Before too long, spasms spread to his right leg and upper limbs. It took a year until dystonia was diagnosed. By then, Albert was in terrible shape. His body was in constant tremor. He couldn't sit or sleep or walk. All he could do was crawl around himself.

In July 2006, when he was 12, Albert underwent Deep Brain Stimulation. This surgical procedure implants an electrode into the brain to block the signals that cause the loss of motor control.

Characterization of striatal short and long term synaptic plasticity in a mouse model of DYT1 dystonia

The striatum is a forebrain region involved in motor control. Our project will characterize the physiological activity of striatal neurons from a mouse model of DYT1 dystonia, observing how they react to pharmacological stimulation, in attempt to understand the basis of this disorder.

Identification of the gene causing paroxysmal kinesigenic dyskinesia

This work is aimed at cloning the gene causing an episodic movement disorder in which dystonia is a prominent finding. Once the gene is identified, study of the encoded protein will lead to new insights into causes of dystonia and ultimately, to better treatments.

Dopamine release in DYT1 Transgenic mice

This study will examine release dynamics of dopamine, a key motor-system

neurotransmitter, in a mouse model of early-onset (DYT1) dystonia. The parallels between this model and human DYT1 dystonia may point to altered dopamine signaling as a contributing factor in human dystonia.

Mouse model of rapid onset dystonia-Parkinsonism and vulnerable basal ganglia neurons

The focus here is to determine whether a mutant mouse that has one copy of the gene that causes a unique, rapid-onset dystonia and Parkinsonism (RDP) instead of two will develop dystonia and Parkinsonism. This can be used for further studies for both prevention and cure.

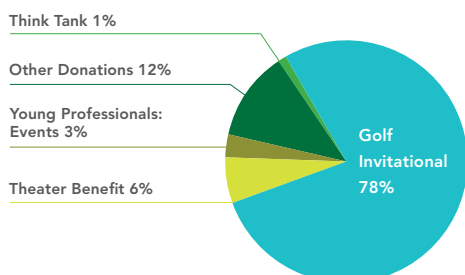

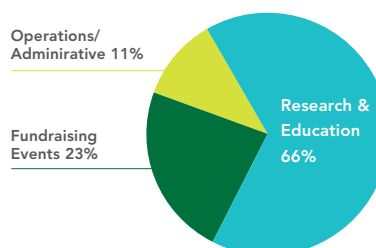
